- I will obey all curfew times (weekdays 10pm and Sunday through Thursday and 12 am weekends Friday and Saturday). If I am going to be late, it is my responsibility to contact the **Alpha and Omega** management immediately. I understand that if i fail to contact **Alpha and Omega** Management regarding my lateness, I would be in violation of this agreement, and I may be excited out of my **Alpha and Omega** Program. _____

I have read and understood the above Alpha and Omega Participant Agreement. I will uphold this agreement while I am at Alpha and Omega Re-entry/transitional Housing Program. I must represent and covenant that, at the time of signing this release of liability; I fully understand its contents and execute it with full knowledge thereof, Violation of above by me, my family, friends and/ or my guest will be considered a breach of this agreement, which may lead to my removal from the **Alpha and Omega** Program. Alpha and Omega House Rules

1. No smoking, vaping in the house.

2. All participants must adhere to the house curfew. Sunday-Thursdays is 10pm and Fridays Saturdays is 12am.
3. All chores must be completed daily.
4. Headphones/ Earbuds are required for personal TV and Radio use.
5. Absolutely No food or drinks are allowed in the rooms.
6. No participants is allowed in any other room than their own.

A Violation of any of these rules is subject to be discharged from the Alpha and Omega Program.

Housekeeping/Chores

1. All participants will be assigned to chores regardless of employment or disability.
2. Participants must do their chores only and must do to the admin's approval.
3. Chores are to be completed by 10 pm (unless on an overnight pass)
4. Check chore assignment regularly as some chore's assignment are subjected to change.
5. Prior to leaving each day, make your bed, turn off your TV, light and fan.

6. Chore's Assignment are posted on the last night of each month

Curfew

1. All participants must be inside Alpha and Omega Transition house by 10pm on weeknights (Sun-Th) and 12am on weekends (Fri-Sat).
2. Participants must Call House manager or administrator if they are going to be arriving home late. An ETA must be Given.
3. Breaking curfew without a call is grounds for immediate discharge from Alpha and Omega Transitional house.

Expectations

1. All participants are expected to actively seek full time employment.
2. All participants are expected to follow parole/probation requirements/restrictions.
3. All participants are expected to clean up after themselves. This includes making their beds and taking out their own trash.
4. All participants are expected to maintain good hygiene.
5. All participants are expected to be courteous and respectful to staff and other residents.
6. All participants are expected to follow all Alpha and Omega Transition house rules.

Kitchen Rules

1. Wash every dish, spoon, fork, Or knife after each use.
2. If you make a mess, clean it up.
3. Stove/ Microwave is to be cleaned after every use.
4. Dishes are to be dried and put away after being washed.
5. The kitchen floor must be swept and mopped nightly.

Laundry

1. Each participants is responsible for washing their own clothes. (staff will not was partcpants's clothes)
2. Clothes left overnight in washer or dryer will be returned once. Any and all times afterward, clothes will be returned with condition.
3. DO NOT overload the washer and dryer.

Weekend/Overnight Passes

1. Weekend or overnight passes are for 48 hours at a time.
2. Passes must be requested in writing 48 hours prior to the date(s) requested.
3. Passes are subject to and do not override, parole or probation restrictions.
4. Only house managers or administrators can approve passes.
